

AGREEMENT FOR RELEASE AND WAIVER OF LIABILITY

I request permission for myself/my children named below (if applicable) to participate in cross-country horseback riding and foxhunting with the Rocky Fork Headley Hunt, Inc.

I fully understand that cross-country horseback riding and foxhunting (which includes riding over fences, other obstacles, and steep and rough terrain) and other equine-related activities involve inherent risks which can cause injury to life and limb. The inherent risk of these equine activities means a danger or condition that is an integral part of such equine activity, including, but not limited to, any of the following:

- a) The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine;
- b) The unpredictability of an equine's reactions to sounds, sudden movement, unfamiliar objects, persons, or other animals;
- c) Hazards, including, but not limited to, surface or subsurface conditions;
- d) Collision with another equine, another animal, a person, or an object;
- e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to act within the ability of the participant;
- f) Tack or equipment failure.

I wish for myself (and my children) to participate in these activities knowing they are dangerous. I accept and assume all the risks of injury (including death) to myself/my children or my property.

In exchange for being permitted to participate in these activities, for myself, my children, my or their heirs, guardians, and legal representatives, I release and agree not to make or bring any claim of any kind against Rocky Fork Headley Hunt, Inc., or its Masters, officers, trustees, directors, members, employees, or guests or any land owners, landholders or other persons making property available for Rocky Fork Headley Hunt, Inc., for any injury (including death) to me or my children, arising out of negligence or otherwise, or any damage to my property from anyone's participation in these dangerous horseback riding, foxhunting or equine-related activities; and I also agree if anyone makes any claims because of any injury to me or my children (including death), or for any damage to my property, I will keep all those released by this agreement free of any damages or costs because of those claims, including all attorney fees and costs.

This waiver shall apply to all circumstances set forth in ORC 2305.321, including personal injuries, property damage and other losses which are presently known, as well as those which are unknown but which may develop or be discovered in the future.
